Drill 6 1/8" hole out of 7 5/8" liner. Drill to total depth of 15,950' on 6/4/97. Rig up Schlumberger, run open hole logs. Driller total depth 15,950', logger TD @ 15,966'. Log open hole from 15,966' to 15,550'. Run in hole with CIBP, set at 15,484' by instructions from Larry "Buddy" Hill with New Mexico OCD. Dump 27' of cement on top of CIBP. Run in hole with bit, tag plug @ 15,460'. Pressure up to 2900 psi for 1 hour, held OK. Release rig 6/6/97.
