Cement w/ 275 sx 'C' w/ 4% gel, 2% CaCl & 0.25 pps celloflake (13.6 ppg & 1.71 cf/sk); tailed w/ 200 sx 'C' w/ 2% CaCl & 0.25 pps celloflake (14.8 ppg & 1.32 cf/sk.) Circ 85 sx to pit. Plugged down @ 11:15 PM MDT 7-14-98. WOC - 12 hrs.

07/15/98 Test blinds to 1000 psi for 30 mins - ok.
