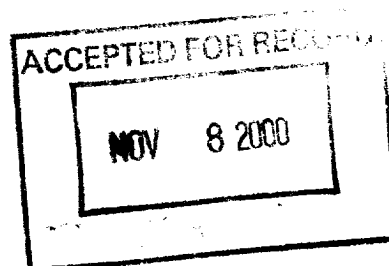

Plug down @ 1900 hrs CDT 10/23/00. Circ 100 sks to surface. WOC 24 hrs. Make cut-off. Weld on WH. NU BOP's & test to 1000#.
