Tested 7-5/8" O.D. casing for 30 minutes with 600 PSI from 6:30 to 7:00 A.M. March 15, 1961. Tested OK. Drilled cement plug and re-tested for 30 minutes with 600 PSI from 9:00 to 9:30 A.M. March 15, 1961. Tested O.K. Job complete 9:30 A.M. March 15, 1961.
