## DETAILS OF WORK

We propose to drill a well using rotary tools to approximately 4,800° to produce the Delemere Sand.  $3-5/8^{\circ}$  casing will be set at approximately 300° or into the anhydrite, circulating the cement to the surface.  $5-1/2^{\circ}$  casing will be set to she production horizon and cemented from the bottom to the base of the salt sections approximately 200 sacks; cement. To run gama ray-mustron log to total depth and to core to establish production horizon. State and Federal Regulations will be complied with. Permission to produce is requested on completion as a producer in commercial quantity.
