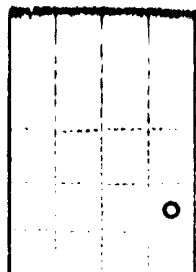

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

Propose to drill and complete a well in the upper part of the Delaware Sand at an approximate total depth of 4835'.

7-5/8" OD new 24 lb. per foot, grade H-40 casing is to be set in an 11" hole at 375', and cemented back to the surface with 275 sx. of regular neat cement.

4 1/2" OD new 9.50 #/ft. J-55 casing is to be set in 6-3/4" hole, on bottom, at approximately 4835', and cemented with 100 sx. of 50-50 Pozmix 2% gel, followed by 50 sx. of Latex cement, to fill approximately 700' between the casing and the 6-3/4" drilled hole.

The well will be drilled with rotary tools. Completion will be made by gun-perforating the pay sections, and applying stimulation treatments based on information gained from preliminary natural tests.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

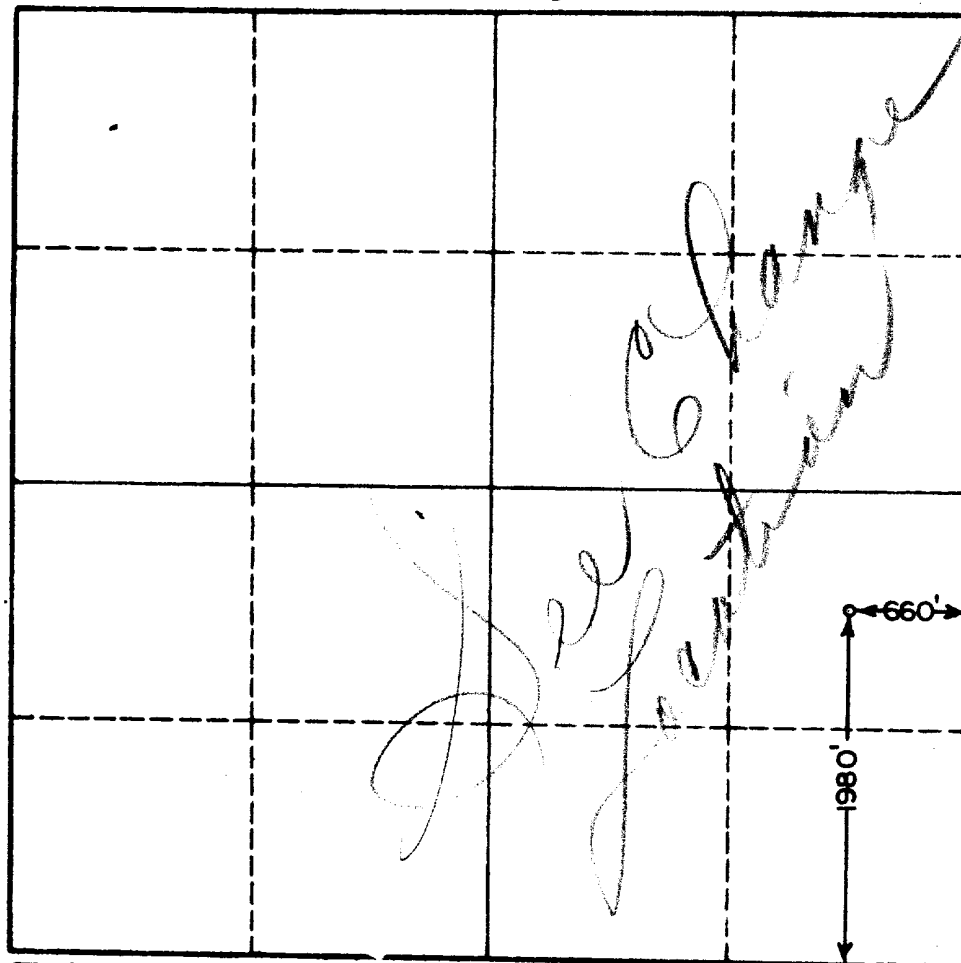
