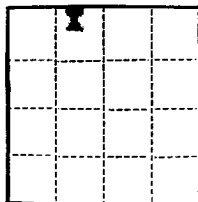

Tested 7-5/8" O.D. casing for 30 minutes with 1000 PSI from 2:00 to 2:30 A.M. February 19, 1961. Tested O.K. Drilled cement plug and re-tested for 30 minutes with 1000 PSI from 4:30 to 5:00 A.M. February 19, 1961. Tested O.K. Job complete 5:00 A.M. February 19, 1961.
