DETAILS OF WORK

It is intended to drill a well with rotary tools at the above location to an approximated TD of 5500'. Casing will be cemented in accordance with GSS standards and other special requirements will be complied with.

The following casing pattern is planned: 10 3/4" OD casing to set at 925' with 1000 sacks cement, cement to be circulated to surface; and 7" OD casing to be set at 5500' with 350 sacks cement. Depths and number of sacks of cement are approximate. Exact amount of cement will be determined by caliper survey.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

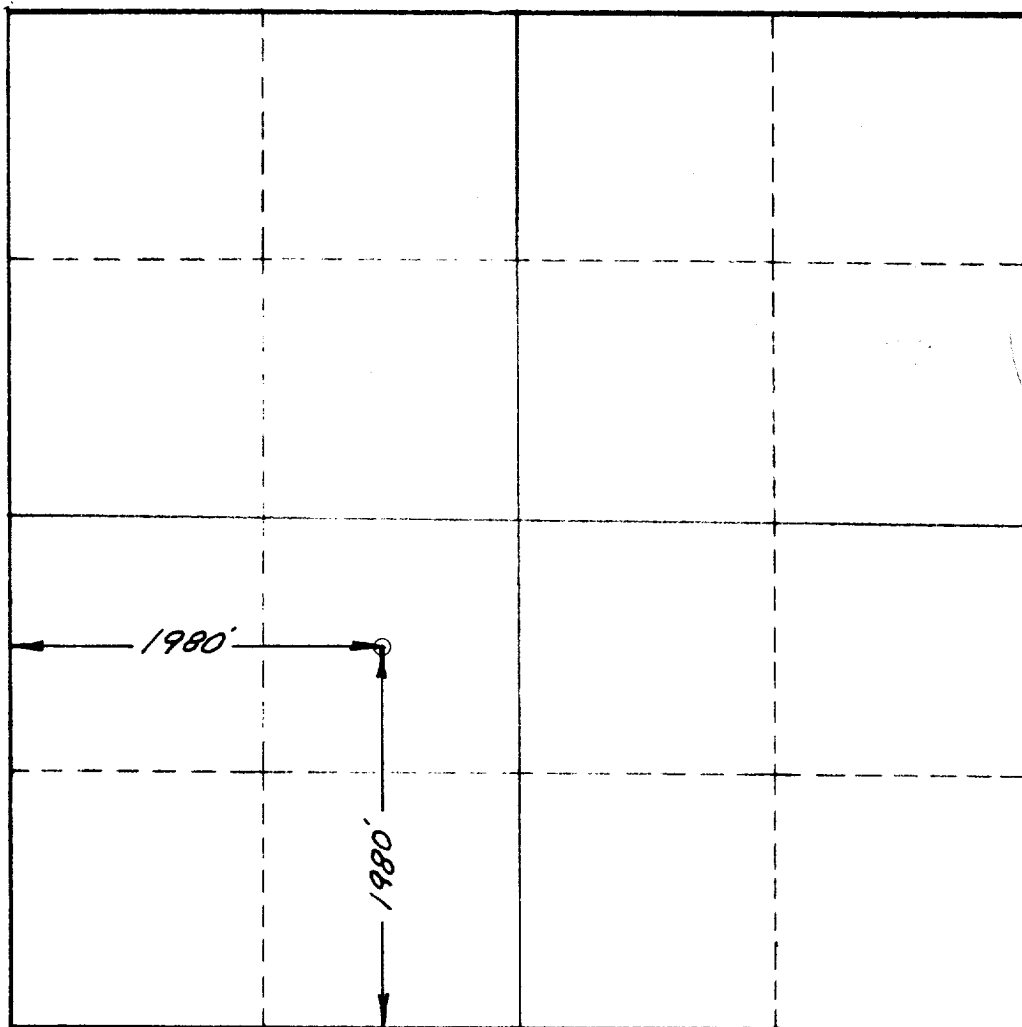
