DETAILS OF WORK

- 2-10-49 Ran 45 joints, 1224.20', 8-5/8" OD 32# 8 rd thd H-40 casing, set at 1234.20'. Cemented with 500 sacks 3% Howcogel cement. Pumped plug to 1214'. Cement did not circulate to surface.
- 2-11-49 Ran 65 sacks 3% Howcogel cement through 1" tubing behind 8-5/8" casing from 208' to surface.
- 2-12-49 Found top cement plug at 1195'. Tested with 1000# for 30 minutes. No pressure loss. Drilled out plug to 1240', tested with 1000# pressure. No pressure loss.
