2851' of 5 1/2" casing was set and cemented with 400 sacks cement, after 6 hours temperature survey was run and cement was found at 1110' from surface. After 48 hours casing was bailed dry and tested 2 hrs. and found dry plug was drilled and again bailed for 2 hrs. and tested for 2 hrs. as both test indicated that a complet shut off had been obtained drilling was resumed.
