FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Present TD 3182- Original TD 3347
Propose to cement back to 3000' in 7"OD Casing through tubing, keeping hole full of heavy mud. Allow to set knock off 7"OD casing at approximately 2600', keeping hole full of heavy mud while pulling. Set 15 sack cement plug in bottom of 10 1/2"OD casing set @ 1450', through tubing, keeping hole full heavy mud, after cement sets knock off 10 1/2"OD casing @ Approx. 200', pulling casing keeping hole full heavy mud to bottom of cellar. Set a piece of 42 pipe of sufficient length to extend 4' above the surface level with 5 sacks cement in bottom of cellar as "Regulation Marker" and fill cellar level with surface.
