1. *Staphylococcus aureus* (ATCC 12228) was grown in tryptic soy broth (TSB) (Difco) supplemented with 0.5% yeast extract (Difco) and 0.5% glucose (Difco) at 37°C. Cells were harvested at mid-log phase (OD<sub>600</sub> = 0.5) and washed with phosphate buffered saline (PBS) (pH 7.4) containing 0.1% bovine serum albumin (BSA) (Sigma). Cells were then resuspended in PBS containing 0.1% BSA and 0.1% penicillin (100 U/ml) (Sigma).

The journal's content became more diverse, encompassing a broader range of literary and cultural studies, and its editorial board expanded to include more prominent scholars in the field.
