FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Due to the above described well having passed its economic production limit on gas lift and due to the inability of doing remedial work as a result of injured or corroded $5-1/2^{*}$ and 7" easing, request is hereby made for permission to plug and abandon. Subject to the approval of the Ofl Conservation Commission, a plug (Coment) will be set in the bottom of the hole and extending up 100' to 150' into the $5-1/2^{*}$ Gasing, which is set at 3368'. By progressively showing and pulling as much $5-1/2^{*}$ casing as possible will then be recovered. The hole will then be comented up into the 7" casing and to the base of the salt. The 7" casing is set at 2391'. The 7" casing above the coment plug will the be progressively shot and pulled to obtain as much 7" casing as possible. The hole will then be filled to near the surface with heavy mud and a ement cap placed on the top of the 10-3/4" surface casing. The 10-3/4" Gasing is set and comented at 493'. No attempt will be made to recover the 10-3/4" casing. In conformity with rules of the Oil Conservation Commission, a suitable marker will be erected at the well site.
