Deepened from 3330' to 3476'. Set 236'10" of 5" OD Liner and cemented with 32 sacks common cement. Bottom of liner set at 3448'

Plugged back from 3476' to 3320'

Casing was perforated with Lane Wells casing perforator gun from 3345-3355 with 22 holes; from 3275-3290' with 36 holes; from 3015-3330 with 24 holes.

Well was completed as ~~well~~ gas well and shut in. Gas volume showed between 5½ and 6 million cu. feet gas.
