In accordance with Rule 1203 application is hereby made on behalf of Apollo Oil Company for an Examiner hearing before the Oil Conservation Commission for the purpose of presenting evidence to obtain Commission approval to dispose of produced oil field brine by injection into the Yates-Sewanee River formation.

Applicant proposes to inject into their Brown No. 5, located 1650' from the North line and 990' from the West line of Section 25, T25S, R36E, open hole interval 3289 to 3363 feet, classified as Jalmat pool.

Control of said injection to be obtained by running 2 3/8" plastic lined tubing with a packer set at 3150 feet as shown by the attached sketch.
