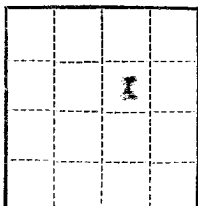

**DETAILS OF WORK**

It is intended to drill this well with rotary tools at the above location to an estimated TD of 3050'. Casing will be set in accordance with U.S.G.S. standards and other special requirements will be complied with.

The following casing pattern is planned: 3 5/8" OD set at 350' with 350 sacks, cement to circulate; 5 1/2" OD set at 3050' with 1100 sacks, cement to return to 1100'. Total amount of cement necessary to set production string will be determined from caliper survey.

Permission is requested to produce this well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
