

Completed 8-30-39, TD 3593'. Shut in since 10-26-57. It is proposed to return this well to production by the following method: Clean out to TD, set 280' of 5" 50 slotted liner at TD. Slots 3338-3593'. Sandfrac with 10,000 gals crude oil, w/10,000# sand and 500# ALUMITE in 4 equal stages with 250# rock salt between stages.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
