It is proposed to convert the well to water injection by the following procedure.

Clear out to 3582 and deepen to 3622. Run Gamma Ray-Neutron and Caliper logs. Run cement lined tubing with packer set at approximately 3350, and tail pipe to 3590. Fill casing-tubing annulus with treated water. Place well on injection.
