It is proposed to use the following procedure to convert the well to water injection.
Clean out to 3611 and deepen to 3641. Run Gamma Ray-Neutron and Caliper logs. Run cement lined tubing with packer set at approximately 3350 and tail pipe to 3625. Fill casing-tubing annulus with treated water. Place well on injection.
