This well is being drilled with cable tools. Water sands had been shut off by setting 15 $\frac{1}{2}$ " and 10 $\frac{1}{2}$ " casing. 8 5/8" O.D. casing has been run to 1450 in the basal Rustler, section and cemented to the surface. The 10 $\frac{1}{2}$ " casing string has been pulled. Casing was cemented on February 12, 1937. It is our intention to test the WSO on February 15, 1937.
