In accordance with Form 9331-a dated 8-19-63, Blinebry Zone completion work performed as follows: After Subb Zone evaluation, set Baker Model "DB" production packer at 5800' and perforated Blinebry intervals 5372-83'; 5395-5403'; 5452-57'; 5475-81'; 5532-42'; 5600-03'; 5610-16'; 5627-30' W/2 SPF. Acidized with 2,900 gallons and evaluated. On PT well flowed 126 BO & 0 BW in 24 hours thru 18/64" choke. TPF 1280, CPC 1280, CPC 1725, GOR 2220.
