2. Reran tubing and packer and set packer at 3250'. Tested casing with 1000 psi for 30 minutes - no pressure drop. Pulled tubing and packer.
3. Cleaned out well to 3510'.
4. Ran Gamma Ray.
5. Ran 108 joints 2" EUE, 8rd tubing with Guiberson Shorty Tension Packer. Set packer at 3286'.
6. Started injection August 19, 1964.
