DETAILS OF WORK

(Confirming telephone conversation with your office 5/10/43:) This well completed in June 1940 has produced approximately 14,590 bbls of oil. The initial production was 33 bbls oil per day flowing after shooting with 240 qts of nitro from 3398' to 3475'. Before shooting and cleaning out the well produced 11 bbls oil in 24 hrs swabbing. The production has declined to approximately 6 bbls oil per day with 315 MCF gas, and cleaning out with cable tools failed to increase the production.

We therefore desire permission to reshoot this well with approx. 400 qts of nitroglycerine from 3398' to 3475' in an effort to materially increase the production. (Total depth 3475' - 7" casing @ 3356')

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
