Filled hole with 12/ mud. Placed cement plug from 3100' to 2500' w/125 sacks. Shot 7" OD casing at 1785' and pulled same leaving 1540' in hole. Failed to pull 10 3/4" casing set at 362'. Placed cement plug from 1850' to 1750' w/50 sx, from 1250' to 1150' w/50 sx, from 400' to 300' w/50 sx and from 50' to surface w/25 sx. Erected 4" markers and leveled location.

10 3/4" casing set at 362'. 7" casing set at 3327'.
