DETAILS OF WORK

Before workover: TD 3372' sand and lime, DF 10', elev 3265' DF. Pay Yates and Seven Rivers 2833-3372' open hole. Csg pt 2833'. Prior to workover, 1958 average daily production was 804 MCF gas.

Work Done: Cleaned out to TD. Ran GRAM log. Cleaned up and resumed flowing.

After workover: TD and pay same as before. Calculated open flow potential 1005 MCFPD. BIP 720 psig. Deliverability at 600 psig 445 MCFPD, at 150 psig 1155 MCFPD. Workover started 5-27-58, completed and tested 6-10-58. Conoco W. I. 25%.
