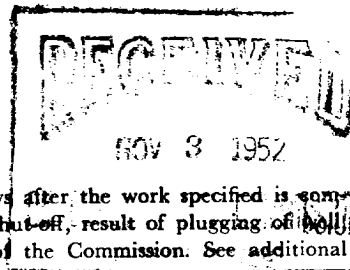

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was recompleted in the Drinkard horizon after plugging off the Devonian section. The procedure used was as follows:

1. Spotted drillable bridge plug at 6600'.
2. Spotted 10' cement on top of plug
3. Test shut-off of Devonian perforations. Tested okay.
4. Washed drinkard perforation from 6350' to 6512' with 500 gallons of 15% regular acid.

Well flowed 113 bbls. of oil in 6 hours through a 3/4" choke.
