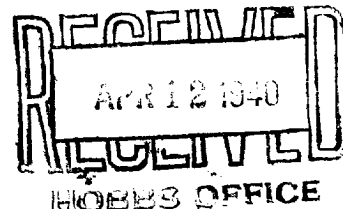

March 4, 1940, perforated 7" casing (by Lane Wells), from 3416' to 3460' with 45 shots at one-foot intervals and from 3285' to 3266' with 20 shots at one-foot intervals

Before: Had hole full water

After: Flowed 3/4 bbls fluid (Mostly water) in 24 hours with 1,989,120 cul ft. gas.
