Tallies 2819', H-11', set @ 2930'. Cemented w/525 sacks 2% HOWCO gel and 125 sacks common bulk cement. Plug @ 2904' Job started @ 3 p.m. and completed @ 7 p.m.

Propose to drill plug and test shut-off @ 7 p.m., May 19, 1949.
