DETAILS OF WORK

7" casing cemented at 3505 with 800 sacks. 7" casing perforated 3425-3450 w/150 shots. Efforts in making this well a commercial producing oil well has thus far proven unsuccessful. We therefore, desire permission, to attempt to complete this well as a commercial gas well by setting a drillable cement retainer at or about 3400' and squeeze off perforated section 3425-3450. Perforate 7" casing 2760-2960 with a minimum of three 1/2" shots per ft. Run tubing into well, swab in, and test.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
