DETAILS OF WORK

Well was completed at total depth of 3531'. 7" production string is set and cemented at 3273' with 200 sacks. Well was shot with 200 quarts nitroglycerine from 3393 to 3531' and was subsequently cleaned out to 3488'. Initial production was flowing 43 barrels PL oil per day with gas oil ratio 12,000.

We propose to clean well out to bottom and to run tubing packer to 3380' in an effort to reduce gas oil ratio, as requested in your letter of July 3rd, 1937.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
