The following workover operations were completed on Westates Federal No. 5 which was formerly a dual completion in the Tubbs Blinberry and Blinberry pay zones.

9-18-73 - Abandoned the Tubbs Blinberry by setting a 6" bridge plug at 5780' with 10' cement on top of plug. Set 6" bridge plug at 5200' above Lower Blinberry perfs 5270' - 5502'. Dumped 10' cement on top of plug. Perfs Blinberry 5041', 5058', 5072', 5076', 5078', 5085', 5090', 5106', 5114', 5127', 5129', 5175', 5177', 5190', 5192', 5200', 5205', 5209', 5213', 5217', 5219', 5221'. (Total 22 holes).

9-19-73 - Acidized new perfs with 40% acid, 1.5% resin, ball sealers.

9-20-73 - Sandfraced new perfs with 40% acid, 1.5% resin, ball sealers and 45,000# 20-40 sand. Max TP 3850%, Min TP 2700%. 10-20-73, 10-21-73, 10-22-73.

9-21-73 to 9-30-73 - Swabbed and flowed new perfs.

10-8-73 - On 24 hour test, Blinberry flow: 190, 100% - 380 MCF, 16/64" ch. FTP 510%.

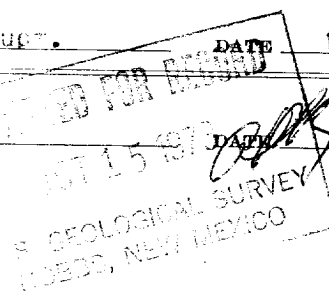

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
