Gentlemen:

A review of our records show that the following wells are in Temporarily Abandoned (TA) status:

If you are to continue the wells in this status you must show that the downhole equipment/casing is in satisfactory condition.

Accordingly, you are hereby requested to submit for approval a program for testing the integrity of the downhole equipment on these wells within 90 days from the date of this letter. Please call the Hobbs office (505) 393-3612 in time for a field inspector to witness all tests.

If a well is found in unsatisfactory condition it will be corrected or the well plugged and abandoned.

If a well is not tested, it will be considered unserviceable and you will be required to plug and abandon the well. Wells tested within the last 12 months will not require retesting provided the test results have been filed and approved by this office.
