10-3/4" casing parted at 2041'.
Spotted 50 sx. cement plug in OH 2041' to 2064', and 50 sx. cement plug in 10-3/4" casing from 1933' to 2041'.

November, 1972:

Pumped 100 bbls. drilling mud in 10-3/4" casing. Spotted 10 sx. cement plug in top of casing. Welded steel plate in top of casing and installed a 4' dry hole marker. Well P&A 11-17-72.
