FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

For the last two or three months we have been/able to get our allowable out for the Humphrey lease on account of the fact that Shell's line will not carry the oil out -- they having a 4" line. Shell has agreed for us to set a pump at the tank battery for wells 1-2-3-4, and we wish permission to flow wells Nos 5 and 6 into this same battery instead of into the battery constructed for these two wells as indicated, so that the pump we have set at the battery for 1-2-3-4 will accommedate wells Nos. 5 & 6 the same as the others. We assume that this arrangement will be temporary, in as much as Shell contemplate laying a 6" line for their gathering system istead of the 4" line now used, which will not carry the oil from thisle-cality because it does not have the capacity.

We will simply lay a flow line from wells Nos 5 and 6 to the battery in the north part of the lease where we have set the pump.

This is all one basic lease -- the royalty owners and also the Working interest owners are the same under all wells.
