RUN 5 1/2" CASING SCRAPER TO 2870'.

SET A 5 SK CLASS "C" CEMENT PLUG WITH 2% CACL2 ADDED FROM 3260' TO 3310'. CAP THE CIBP AT 3310'.

SET A CIBP AT 2830', CAP WITH 20 SKS CEMENT UP TO 2610'. CEMENT WILL COVER THE BASE OF THE SALT AND THE OPEN PERFS DOWNHOLE.

CIRCULATE HOLE WITH 9 PPG BRINE UP TO 1500'. SET A 12SK CEMENT PLUG FROM 1380' - 1500'. CIRCULATE HOLE WITH 9 PPG BRINE UP TO 366'.

RUN PERFORATING GUNS TO 366', PERFORATE FOUR SQUEEZE HOLES, OPEN BRADENHEAD AND ESTABLISH CIRCULATION OF H2O TO SURFACE. PUMP 95 SKS CEMENT DOWN CASING AND THROUGH PERFS (ASSUMING 50% EFFICIENCY IN OPEN HOLE) ACROSS SURFACE CASING SHOE ALLOWING IT TO CIRCULATE OUT BRADENHEAD. DO NOT DISPLACE.

CUT OFF CASING 3 FEET FROM SURFACE, INSTALL P&A MONUMENT. CLEAR AND RESTORE LOCATION.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
