1. March 15, 1975, re-entered well and pulled tubing, rods & pump.
2. Cleaned out well to original TD 3440' and deepened to TD 3660' (4-3/4" hole)
3. March 22, 1975, logged well to TD.
4. March 24, 1975, TD 3660'. Set 12 jts. (490.6') of 4" 10.46# liner @ 3660' and cemented w/75 sx. Class "C" 50/50 Pozmix and 2% CaCl and 1/4# Cello-flake/sx.
5. March 26, 1975, drilled out cement to top of 4" liner and press. casing to 1000# w/no dec. in pressure.
6. March 27, 1975, drilled out cement in 4" liner and press. liner to 1000# w/no dec. in pressure.
7. At the present time, we are waiting on a completion unit to complete this well.
