FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

The above well has been drilled to a total depth of 3441' without encountering commercial production. We propose to plug the well in the following manner. Fill with mud from 3441 to 3200, cement from 3200 to 3100, mud 3100 to 1350, cement from 1350 to 1250, mud from 1250 to 260, cement from 260 to 200, mud from 200 to the bottom of the cellar. We will cement the cellar and mark the location with a 4" steel marker extending 4' above the mean ground level. Both the 7" and 8 5/8" casing will be shot at various points until loose. We have notified all offset lease owners and have received verbal permission from Mr. F. J. Vesely to proceed with this work. Plugging operations will be started November 15, 1935.
