It is proposed to perform the following remedial operations on the subject well:

1. Deepen from present TD of 3392' to approximately 3500' with reverse drilling equipment.
2. Cement a 4" OD flush joint liner from approximately 2960' to new TD (5½' casing presently set at 3017').
3. Test liner.
4. Run GR/N log and perforate.
5. Stimulate with acid and frac.
6. Recover load.
7. Conduct production test after recovery of load.
