Risers are installed and the subject well was inspected August 2, 1977, by Mr. Melvin Crossland of the Oil Conservation Commission.

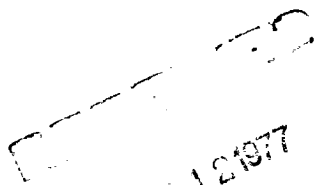
Since risers are installed and below ground level connections have been inspected, we respectfully request an Exception to the provision of digging out the cellar during annual inspections.
