2. Spot 25 sx plug 2250'-2350' (spot via tubing).
3. Perforated 5-1/2" casing @ 1175', set retainer @ 1070' w/35' cement on top. Circulate 200 sx cement.
4. Cut off casing and spot 10 sx cement, plug at surface.
5. Welded on steel plate and marker.
