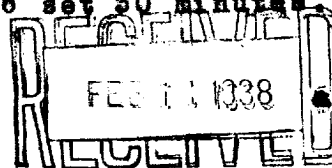

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Set 7-5/8" Casing at 974' with 300 sack common cement and 50 sacks quick set cement at noon on February 7, 1938. Well was allowed to set 48 hours undisturbed, then tested before and after drilling plug with 1000# pressure, and allowed to set 30 minutes. Satisfactory test was obtained
