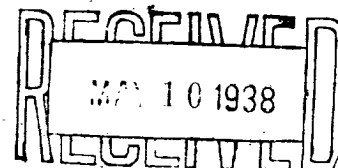

This Casing Will Be Allowed To Stand Undisturbed For 72 Hours, The Casing And Connections Will Then Be Tested With 1200# Pump Pressure And Allowed To Stand Undisturbed For Thirty Minutes, If No Drop In Pressure Results The Cement Will Then Be Drilled Out Of The Casing And The Same Tested With 1200# Pump Pressure, And Will Be Allowed To Stand Thirty Minutes Undisturbed, And If Not Drop In Pressure Results The Drilling Will Then Be Resumed,
