FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to fracture treat as follows:

1. Pull tubing.
2. Run steel line measurement. Clean out with sand pump if necessary.
3. Run 2-7/8" tubing with Hookwall packer and hydraulic holddown, set in base of 7" casing.
4. Treat formation from 3262-3375' with 10,000 gallons gelled lease oil with 1# sand per gallon.
5. Pull 2-7/8" tubing, packer and holddown. Run 2-3/8" tubing and return well to production.
