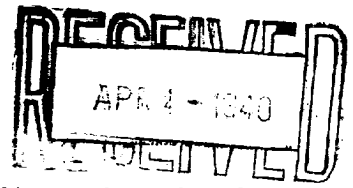

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran temperature survey, cleaned hole to bottom and drilled deeper, from 3330' to 3410'. Drilled pay carrying some oil with gas 3340/50 and 3355/60; main oil pay carrying approximately 50 bbls/24 hrs. 3390/3410. Ran packer on 2-1/2" tubing and set at 3333'. Pumped 160 lbs. fibretex and 7 sacks aquagel in casing as packer seal; seal did not hold and was flowed out. After deepening and setting packer, well tested 45.60 bbls. oil in 24 hrs. flowing with gas-oil ratio of 10550/1. Before workover, well was producing 23 bbls. oil per day with gas-oil ratio of 65142/1.
