Total depth 3159'. Ran 3112' of 7" 23# casing set at 3118'. Used 450 sacks cement 3% gel. 200 at shoe and 250 thru 2-stage tool set at 1114'. Plugged down at 3:30 A.M. 12-26-52.

Drilled cement and float. Applied 500# pressure and held for 15 minutes. Shut off okay.

Reason for changing casing program was to include additional pay sections not anticipated.
