To convert this well to injection service as authorized by Order No. 4022, we plan to do the following work:

1. Pull tubing.
2. Squeeze casing perforations 2898'-3073'.
3. Drill out cement and test squeeze job.
4. Clean out to TD of 3350'.
5. Run internally cement lined tubing and tension packer.
6. Set tension packer at 3180' (5½" casing is set at 3237').
7. Load annulus with inhibited fluid and install pressure gauge on annulus.
