Pull producing equipment. Set CI BP at 2708'. Load casing with abandonment mud. Spot 5 sacks of Class C cement plug on top of BP at 2708' to 2660', abandoning open hole interval 2880' to 3125'. Spot 11 sack, 106', of Class C cement plug from 1180' to 1074', across top of salt at 1130'. Spot 11 sacks, 106', Class C cement plug from 376' to 270', across 8-5/8" casing shoe at 322'. Spot 6 sacks, 57', Class C cement plug from 65' to surface. Install dry hole marker and clean location.
