Ran 84 jts. 5 1/2", 15.5#, API, J-55 Casing.

Cemented casing w/250 sax through shoe at 3285'. Cemented w/150 sax through Halliburton DV stage cementer at 1160'. W.O.C. 24 hrs.

Cleaned out to top of D.V. tool. Closed rams and tested w/500# pressure. Drilled out D.V. plugs. Tested again w/500#. Drilled out cement to 3275'. Closed rams and tested again w/1000# pressure. Drilled out remaining cement and cleaned out to bottom.
