The drilling bond which you submitted is returned herewith with these matters called to your attention.

First: The attorney in fact of the Surety Company has not executed the affidavit showing his authority to execute this bond for his company.

Second: The principal, "A. R. Eppenauer, DBA Eppenauer Drilling Company, a Proprietorship" is too indefinite; and it is not quite clear to me who is intended as the principal. Is A. R. Eppenauer as agent executing this bond for Eppenauer Drilling Company, a proprietorship? If so, is Eppenauer Drilling the principal, and in that case what kind of Association is the Eppenauer Drilling Company, a copartnership, corporation or what?

In case A. R. Eppenauer is executing this bond for his company, he must show his authority in an affidavit similar to the one for the Surety Company as indicated in the instructions at the top of the bond form.

The bond when finally passed upon by the Commission and approved is filed with the Commission.
