- Procedure: (1) GIH and set CIBP 100' above current perfs and dump 5 sxs. cement on top.
(2) Log Yates - Seven Rivers Queen Zone.
(3) Test casing to 2000 psi.
(4) Perf. Yates section picked from logs.
(5) Acid and frac the perforated zone.
